Honorable Chief Justice and Associate Justices,

The League for Protection and Architectural Heritage Association cases have made clear that when a historic resource not listed in the California State Register is threatened, the 'fair argument' standard applies to the question of whether the resource meets criteria for listing in the Register and is thus treated as historic for purposes of CEQA review. Expert opinion is sufficient to raise the 'fair argument,' and an EIR process is then triggered, providing consideration of feasible alternatives to the demolition of a historic resource.

Three cases now, including the subject case, have held to the contrary, that the 'fair argument standard' does not apply, which leads to the demolition of historic resources because one development-driven report asserting an opinion of ineligibility for the State Register can override abundant expert testimony that the resource is eligible. The result is demolition because there is no EIR to consider the feasibility of adaptive reuse.

Numerous important historic resources will certainly be lost if this case is not reviewed or depublished. SOHO requests review, grant and transfer, or depublication.
